Commissioner Ephyro Luis B. Amatong was appointed a commissioner of the Securities and Exchange Commission (SEC) in 2014, and is currently the supervising commissioner for the Markets and Securities Regulation Department and the Economic Research and Training Department.

Before joining the SEC, Mr. Amatong was an Assistant Secretary of the Department of Finance (DOF) where he had an active role in the privatization of 74 hectares of the Food Terminal, Inc. (P24 billion). He was also involved in a number of Public-Private Partnership (PPP) projects such as the PPP for School Infrastructure Project Phase I (US\$397 million), the NAIA Expressway Project (US\$345 million), and the Automated Fare Collection System (US\$38 million).

He also served in various capacities in the government, namely as Vice President of the Philippine Deposit Insurance Corporation (2012–2013), Corporate Staff Officer of the National Power Corporation (2010–2012), Acting Chairman of the Local Water Utilities Administration (2011), Corporate Legal Counsel and Assistant Corporate Secretary of PNOC Exploration Corporation (2008–2010), Adviser to Amb. Hilario G. Davide, Jr. of the Permanent Mission of the Philippines to the United Nations (2007–2008), and Senior Law Clerk to then Justice Conchita Carpio Morales of the Supreme Court of the Philippines (2003–2005).



Michael Sheren is Senior Advisor within the Prudential Regulation Authority division of the Bank of England. In his role, he provides counsel and independent challenge to senior management on matters concerning policy, governance, supervision and research relating to the financial markets. Michael is one of the leaders within the green finance space within the Bank of England. On behalf of the BoE, Mr Sheren cochaired the G20 Sustainable Finance Study Group with China from 2016 to 2018 and is currently a delegate to the G20 Infrastructure Working Group and the NGFS. Additionally, he is actively involved in the Banks work in the areas of fintech and digital finance. Prior to Joining the Bank, Mr Sheren spent over 25 years in the debt capital markets where he specialized in the structuring, distribution and trading of commercial debt for major global financial institutions in New York and London.



Udetanshu is an energy finance specialist, with a focus on using data and financial, policy and regulatory analysis to help drive just transition to clean energy. She is working with the Global transition team at RMI, helping shape its direction and technical tools and models, with a nearterm focus on Southeast Asia.

She brings a strong track record across M&A, financing, project development and investment, policy consulting and innovative solutions for the energy, power and infrastructure sectors working in diverse geographies. Her experience spans 10 years in Investment Banking working with financial institutions and corporates and 6 years consulting with governments, financiers and regulators. She also developed an investment and development platform for utility scale solar and wind in Vietnam.



Francis Pigeon joined Environment and Climate Change Canada (ECCC) in May 2018 as the Director, Climate Finance and Partnerships. Central to his role is delivering on Canada's climate finance commitments, including to provide \$2.65 billion CAD over 2015-2020 in support of developing countries' transition to low-carbon economies. In his role, he also advances Canada's engagement in strategic international partnerships such as the Powering Past Coal Alliance and the Climate and Clean Air Coalition.

Prior to joining ECCC, he oversaw the management of Canada's International Assistance Envelope, a dedicated fund used to support Canadian international assistance activities valued at approximately \$6 billion CAD annually. In that function, he supported the Ministers of Foreign Affairs and International Development in their function as comanagers of the Envelope as well as to lead the Department's efforts through the federal budget process.

Over the years, he played various functions in a number of federal organizations that allowed him to develop a unique specialization in policy development and financial management in both domestic and international contexts.

Francis holds a Masters in International Relations and a Baccalaureate in Political Sciences and International Development.

He also led the IEA's work on electricity system technologies, such as Smart Grids.

Over the course of his career David has worked in the energy and climate fields for over 20 years, with focus areas of technology, policy and analysis in both private and public sectors. In these roles he developed markets, deployed renewable and energy efficiency technologies and has advised various governments at the local and national levels on energy policy.



Michael Williamson is Section Chief of the Energy Division in the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP). He works on regional cooperation for sustainable energy and energy connectivity across ESCAP's 53 member countries, spearheading the Division's intergovernmental, technical assistance and knowledge building efforts. Prior to this, Michael was the acting Director of UNESCAP's Subregional Office for South and South West Asia overseeing 10 countries of South and South West Asia. From 2015 to 2017 he was Chief of Staff and Senior Adviser to the Executive Secretary of UNESCAP in Bangkok. He began his UN career in in India in 2013 as the Head of the Asian and Pacific Centre for Transfer of Technology, a regional institution of UNESCAP.
